URTS - Utility Relocation Tracking System


- LA DOTD uses a database program to assist DOTD utility personnel in the tracking of all utility relocation agreements required. The current program is called URTS Utility Relocation Tracking System.
- The program gives access to over 40 form letters and inserts project and company information into the text of the letter where specified.
- DOTD utility personnel are able to see the status of key information on a project. Some fields are auto populated while other fields require manual input from personnel.

LA DOTD's means of tracking utility agreements on a project has transformed over the decades.






The department's latest database system, URTS (Utility Relocation Tracking System), was designed so utility agreements and utility invoices could be tracked on any given project.


The current system was designed to be used by DOTD district and headquarters utility personnel.




The program allows all projects in the system to be viewed at any time.



Preset form letters are easily generated to send to individual utility companies for a selected project.




Letters for other sections within the department may be selected and the date of generation tracked.




<u>URTS stores data such as:</u>

- Summary of all agreements on a particular project


